Synopsis	These north-trending faults parallel the trend of eruptive centers in the late Quate Mount Bachelor volcanic chain in central Oregon. No detailed information on Quaternary offset are available, but limited airphoto and DEM analysis suggests possible Quaternary displacement.
Name comments	These unnamed faults are located south of Kiwa Butte in central Oregon (Pezzop 1993 #3544; Geomatrix Consultants Inc., 1995 #3593; Weldon and others, 2002 #5648).
